- **Export Experience:** Some categories of FIEO membership might require a minimum export turnover or experience in export activities.
- **Valid Importer-Exporter Code (IEC):** You must have a valid IEC issued by the Directorate General of Foreign Trade (DGFT).
- **Business Registration:** The business entity must be registered under Indian laws, such as a Private Limited Company, Limited Liability Partnership (LLP), or Partnership firm.

1. Members of FIEO must select from available membership options which are divided by business categories including exporter, manufacturer, merchant, service provider, etc.

- **Step 3: Complete the Application Form**

1. Business name
2. Type of business
3. Contact details
4. **Import Export Code** (IEC) number
5. Export turnover (if applicable)
6. Trade products/services

- **Step 4: Submit the Documents**

1. A copy of the IEC certificate
2. A copy of your business registration certificate (e.g., Certificate of Incorporation)
3. **PAN card** of the business entity
4. **GST registration** (if applicable)
5. Proof of export experience (if applicable)

- **Step 5: Payment of Fees**

1. FIEO membership comes with an annual fee. The fee varies depending on the type of membership and the size of your business. You can pay the fee online via the FIEO website.

- **Step 6: Wait for Approval**

1. Once you have submitted the application form and the required documents, FIEO will process your application. If everything is in order, you will receive your membership approval.

- **Step 7: Membership Confirmation**

1. Upon successful registration, you will receive your FIEO membership certificate, granting you access to the various benefits associated with the membership.

## **Types of FIEO Memberships**

- Regular members comprise exporters who run companies of small or average size and maintain the eligibility requirements.
- Associate Membership serves businesses working in export that want to build participation steadily toward expanded operations.
- Life Membership grants all ordinary membership advantages with no requirements to renew after initial purchase.
- The corporate membership aligns with companies conducting comprehensive export operations at a large scale.
- Organizations participating in export service sectors can join this category if their primary operations focus on export-related consultancy and logistical activities and financial export support.
